### DETERMINING YOUR ACEC & ACEC/MO INDEX NUMBER

In determining the ACEC Index Number, all principals, officers, and full-time employees of the entire firm should be used. Disregard if already an ACEC member in another state.

In determining the ACEC/MO Index Number, all principals, officers, and full-time employees of the firm employed in Missouri offices should be used. Where personnel complement fluctuates, the average number of personnel during the preceding year should be used.

#### PAYMENT SCHEDULES:

Annually, Semi-annually or Quarterly as the member wishes.

#### NEW MEMBERS:

Pay a one-time Membership Processing Fee of \$100.00.
